C-2. Student Recognition

Students at William Marvin Bass Elementary School took the top three spots in this year's 24 Game challenge. In addition to placing fourth in this year's 24 Game challenge, a student from Robert S. C-3. Student Recognition

The EC Glass Rock Band welcomes musicians of all skill levels and expanded this year to form a "Garage Band" designed for students on a beginner to intermediate skill level. Students have the opportunity to perform at school events as well as events throughout the community such as Thirsty Thursdays at the American Legion. This summer, the students will also perform their first "stadium show" at a Lynchburg Hillcats game! Several EC Glass Rock Band alumni have gone on to study modern music at notable music schools including James Madison University, Middle Tennessee State, and Eastern Carolina University, and you may also witness a few at local music venues who have jumped headfirst into Central Virginia's own professional music scene. With help from an LCS Classroom Innovation Grant, the EC Glass Rock Band was able to spend two days at The Recording Zone, a topnotch recording facility just outside of Lynchburg. Under the direct tutelage of Engineer Jhon Ackerman, the students learned about the process of recording an album "from scratch" including microphone placement, tracking, mixing, over dubbing, and numerous other recording techniques used by music industry professionals. The students recorded songs by Paramore, Thin Lizzy, Christina Perry, and The Arctic Monkeys. They released their album May 6 at the 23rd Annual Classroom Innovation Grants Reception at E. C. Glass High School.

F-1. School Nutrition Program: Summer Program

The School Nutrition Program is seeking school board approval to begin a program to provide free summer meals to children in several Lynchburg communities. The program is called the "School Food Service Program" and is administered through the Virginia Department of Health.

Through this program, Lynchburg City Schools will be able to provide breakfast and lunch to students in the Robert S. Payne Elementary School and Perrymont Elementary School communities. Students under the age of 18 will be provided meals for free. Adults can purchase meals for a nominal fee.

G-1. Foreign Travel: Heritage High School

Mrs. Catherine Runion and Mrs. Michele Wisskerchen are planning a trip to Costa Rica for students at Heritage High School scheduled to occur in June 2016. School Board Policy 6-42: Field/Recreation/Class/Athletic Trips requires prior approval by the school board for student travel outside the continental United States.

This nine-day trip will meld bilology and Spanish as student travel from the mountains to the coast. Student eligibility will be determined by GPA and behavior referrals. Up to 150 students will have the opportunity to participate. There will be one chaperone per six students, and there will be monthly meetings with parents beginning six months prior to the trip to outline rules and expectations. The cost of the trip, which can be paid for in monthly installments, includes insurance.

This item will be considered for action at the next meeting.

G-2. K-12 Math Vision and Plan: 2015-16

The curriculum and instruction team has been involved in reviewing the approach to math instruction and courses. As a result of that review and meetings with a variety of stakeholders over the last several months, a vision and plan has been developed for increasing math learning at the elementary, middle, and high school levels.

The five key principles to guide the vision and direction are:

- 1. Remove the Ceiling: While we advance students in reading who go beyond the base grade level expectations, it is not as common for math. Student who demonstrate readiness to go beyond grade level expectations will be given the opportunity to do so.
- 2. Respond Fluidly to Student Needs and Abilities: Students will be advanced based on units of ability not necessarily based on whole year ability. Students who are ready for advanced content for a whole year will still have that access while those ready for advancement in some units will have that access when needed.
- 3. Establish Clear Criteria for Advancement: As student approach middle school, courses emerge that are fixed across a semester and year, and there needs to be clear criteria for determining the appropriate course for a students. These criteria should include achievement data that represents student proficiency with content that should have been mastered from the prior year. There also needs to be clear criteria that includes teacher and student/parent input.
- 4. Ensure a Strong Foundation: A bridge class will be designed for students to create a stronger foundation for success in Algebra I that will help prevent failure and provide for success. A review of sixth, seventh, and eighth grade classes with be performed with more of a bridge mindset in the double block math class.
- 5. Involve and Invest Students and Families: Ensure that rules and criteria are clear for all families so that when there is an opportunity to do so, students can meet with counselors to plot a course for how the goals of a course can be met. Achievement courses should suggest courses, but students and parents should be allowed to reach beyond when they are ready.

G-3. Capital Improvement Plan: Robert S. Payne Elementary School

The 2014-15 capital improvement plan includes \$60,000 in building improvement funding for replacement of the Robert S. Payne Elementary School gymnasium floor.

A total of two bids for the gym floor replacement project were received. The school administration recommends J. W. Squire, Inc. based on their bid of \$43,865, which was the lowest bid. All bids received are listed below.

G-4. Educational Technology Series XV (Spring 2015)/e-Learning Backpack Notes

The Virginia Department of Education has notified Lynchburg City Schools that its share of the Educational Technology Series XV (Spring 2015) Grant Funds will be \$466,000. A 20 percent matching expenditure of \$93,200 is required. Grant funds may be expended on networking/infrastructure equipment, classroom multimedia network computers, instructional software, and local technology plan hardware. Purchases from these funds are financed by Virginia Public School Authority Bonds, which are sold in the spring of each year.

In addition Lynchburg City Schools has been notified that its share of the e-Learning Backpack Grant Funds will be \$260,000. A 20 percent matching expenditure of \$52,000 is required. e-Learning Backpack funds may be spent on a portable device. The amount is based on \$400.00 per student for the prior year's 9th grade enrolment.

Ordinarily, these funds may not be spent more than 60 days prior to the date the bonds are sold. However, a school division may spend funds prior to that date and be reimbursed for those expenditures if the school board passes a resolution stating its intention to do so. A resolution stating the school board's intention to be reimbursed for expenditures is attached for school board consideration.

The Central Virginia Governor's School for Science and Technology, the LAUREL Regional Special Education Program, and the Secondary Alternative Education Program are also eligible for \$26,000 each. There is no local match required for these grants. The resolution attached to the agenda report referred to these funds as well.

G-6. Virginia High School League

At a special called meeting of the general membership of the Virginia High School League, voting members supported the VHSL's executive committee's recommendation to resolve the pending litigation between the Virginia High School League and Liberty Christian Academy.

One year ago, LCA filed an anti-trust law suit against the VHSL. The law suit was preceded by attempts by LCA to join the VHSL through petitions, beginning in 2006. The VHSL executive committee, by a vote of 28-1 approved a resolution on April 16 and ratified the resolution by a vote of 25-0 on May 7. The resolution was then presented to the general membership on May 20, at which time the executive committee's motion was supported.

Through the resolution the executive director and chairman were authorized to enter into an agreement with LCA to resolve the pending litigation between the VHSL and LCA, including but not limited to amending the VHSL bylaws and handbook to permit private school membership, "setting such rules and procedures as are equitable to public and private schools."

The mission of the VHSL to was changed to include *non-boarding non-public high schools*. Eligibility and membership in VHSL was also changed to include *non-boarding, non-public high schools which agree to follow VHSL by-laws, rules, and regulations as amended for them.* LCA was added as a member of the Seminole District, joining Heritage, E. C. Glass, Amherst, Brookville, Jefferson Forest, Liberty (Bedford), and Rustburg. LCA will also be a member of Conference 23 of 4A West, joining E. C. Glass, Charlottesville, G. W. Danville, Amherst, and Jefferson Forest. LCA's attendance zone will be defined as the attendance zone of the VHSL member public school in which it is located (Heritage High School) and the attendance zone of one additional public school contiguous to the public school attendance zone in which it is located (E. C. Glass High School).

The first time during high school that a student transfers without a corresponding parent move between a member public school and a member non-public school in the non-public school's declared attendance zone, the student is exempted from the normal one-year eligibility delay. If a high school student living in a county school zone transfers to LCA from Brookville, Jefferson Forest, or Amherst, the student must sit out one year before becoming eligible. A high school student living in either the Heritage or Glass zone transfers to LCA and is immediately eligible and does not have the one-year wait period. A student who enrolls in a high school for the first time as an eighth or ninth grade student is immediately eligible and remains eligible at that high school unless the transfer rule comes into effect. An incoming ninth grade student who lives in any public school zone and who chooses to enroll in LCA instead will be eligible immediately and will remain eligible at LCA for as long as he/she is enrolled there.

The semester rule (a student is eligible for eight semesters from initial enrollment) is waived for a student at a non-public member school if the student participated in Varsity athletics as an eighth grade student. The semester rule is waived if the student at a non-public member school repeated a high school grade and therefore is, or in the future will be, a fifth year senior. The semester rule waiver will apply to each designated student currently enrolled.

LCA will be eligible for post-season play in all sports beginning in 2015-16. Eligibility includes football playoffs even though LCA will not compete against any VHSL public schools during the regular season. Schedules at both high schools are completed for next year; therefore, except for previously scheduled contests involving LCA, no contests between LCA and a city school with take place in 2015-16.

Seminole District schools will revise their 2016-17 schedules to include LCA in all sports except varsity and junior varsity football. Seminole District schools will not play LCA in Varsity or Junior Varsity football in 2015-16 or 2016-17 unless a school has a non-district opening. Seminole District schools will include LCA in the master schedule for all sports for the next cycle, 2017-18 and 2018-19, including Varsity and Junior Varsity football.

Does the eight-semester rule and transfer rule create a level playing field for our students? Further, there is to be no publicly-sponsored prayer or publicly-sponsored invocation at VHSL state events. Privately-sponsored prayer, whether the speech of students or private schools, is not prohibited at VHSL state events. What does this mean for our students when they play at LCA? Protection for LBGT students from discrimination will also come into the mix. Does playing a school opposed to LBGT students send our students a mixed message about our support for them? If we are to be under the same rules on the field of play, we should be under the same rules in the field of study. Should we require any school joining the VHSL to submit to the same state accountability system, including SOLs and the revised state report card?

Given the number of concerns, the school administration recommends that the 2015-16 legislative agenda include the formation of a state advisory group that will review and assess the impact of this agreement on Virginia public education. This item will be discussed at future school board meetings.

H. Superintendent's Comments

Dr. Brabrand offered remarks about the LAUREL Regional School graduation that occurred Monday evening.

Sandusky Elementary School celebrated its 50-year anniversary Monday inviting teachers and administrators who had been at the school to the celebratory activities.

Dr. Brabrand announced that Diane Swain is retiring after 46 years with the Lynchburg City Schools, 26 as principal at Sheffield Elementary School

Friday marks the last day of school for the 2014-15 school year. Graduation for Heritage High School and E. C. Glass High School will occur on Sunday.

Summer school registration will occur on June 23 beginning at 8:30 a.m. and ending at 5:30 p.m. at Linkhorne Middle School.

Dr. Brabrand recognized Mr. Webb for the great knowledge and wisdom he brought as a school board member. He will be missed.

I. Board Comments

Ms. Waller provided information about the events and activities she attended during the past two weeks. She also recognized Mr. Webb's departure as school board member.

Ms. Hoss declared her admiration for Mr. Webb as a board member and his dedication to putting children first. She will miss his wisdom.

Mr. White stated that it would be difficult to find any board member in Lynchburg City Schools' history who has given more of themselves to the school division than Mr. Webb. Mr. White thanked Mr. Webb for his dedication and commitment to education.

Ms. Poore stated that Mr. Webb's commitment to the community is invaluable and she has learned a great deal about being a good community member from him.

Dr. Nilles thanked Mr. Webb for the good perspective he brought to the board table. He stated that it had been an honor sitting next to Mr. Webb and getting to know him.

Dr. Coleman praised Mr. Webb for his compassion and thanked him for helping him to appreciate what being a school board member is all about.

Mrs. Snyder thanked Mr. Webb for sharing his wisdom. She will miss him being on the board.
