F-1. Special Education Advisory Committee: 2016-17 Report

State regulations governing the education of students with disabilities outline the role of your Local Special Education Advisory Committee (SEAC) including their annual responsibility to advise the school division of the needs in the education of students with disabilities. In addition, this advisory committee also provide an opportunity for parents and interested community members to have a voice in the way school division provide services to students with disabilities.

Ms. Sydney Gunn and Renee Maca, co-chairs of the SEAC, provided the school board with recommendations for the 2016-17 school year. Those recommendations are as follows:

- continue to implement and develop inclusive practices for all learners;
- provide professional development for special education teachers in the areas of dyslexia, behavior, and assistive technology;
- develop case manager and special education leads responsibilities and expectations documents and distribute them to the staff as clarity documents;
- determine if there is a need for a special education program where students with mild disabilities receive an additional year of Early Childhood Special Education experience before entering Kindergarten;
- conduct a review of transportation data related to the time students with disabilities (enrolled in division-wide
- programs) spend on the bus in comparison to the time students without disabilities spend on the bus as they travel to programs such as the schools for innovation; and
- conduct a review of all division-wide programs, including projected enrollment, to determine the possibility of educating students with disabilities in their home schools so students can attend school with their zoned, non-disabled peers,

with an emphasis on middle school students.

The SEAC is very appreciative of the various programs and opportunities afforded to students with disabilities. Members of this advisory committee also appreciated the opportunity to present these recommendations to the school board.

F-2. Employee Demographics Report

The Lynchburg City Schools employs highly qualified teachers and staff who work to support the students in our community in a variety of ways. Teachers and instructional assistants are hired to provide instructional activities and educational programs that will give students the skills and the knowledge to lead them to graduation. Personnel such as bus drivers, custodians, and health assistants are just a few of the employees that offer the day-to-day support that is critical to the operations of the school division. In order to recruit and retain those individuals, the school administration has recommended pay increases and adjusted compensation for specific employee groups. Further, professional development activities for teachers have increased, and leadership institutes have been created for those who wish to become leaders in the school division.

During this presentation, the school administration provided the school board with information about recruitment, retention, and demographics for the school division's employees.

F-3. Request for Reallocation of Budget

The school administration has recognized a need to reallocate funds to various salary and operating accounts throughout the school division. Funds to:

F-4. Capital Improvement Plan: Paul Laurence Dunbar Middle School for Innovation

The capital improvement plan includes \$130,000 in construction funding for replacement of the windows at Paul Laurence Dunbar Middle School for Innovation. The city of Lynchburg Office of Procurement and Purchasing has received bids on the project.

A total of three bids for the Dunbar window replacement project was received. The school administration recommends Appomattox Glass based on their base bid of \$179,690, which was the lowest bid and the alternate bid of \$76,210. Additional funding required for the project will be transferred by the CIP contingency account.

H. Board Comments

Dr. Dolan-Sewell read the following statement on behalf of Dr. Nilles: "Our political climate is highly polarized and has been for a long time. Recent election results brought a surge of emotions on both sides. Controversial comments were posted on line. Ms. Poore recognizing that service on the board is incompatible with her desire to speak out chose to resign.

"During her time on the school board, she was a sincere and committed advocate for public education in the city of Lynchburg, and I appreciate her desire to do what's best for the school division."

Ms. Carter announced that she had attend the Anne Spencer Poetry Contest. There were so many talented students who participated in this contest. She also attended the open house for the Central Virginia Governor's School for Science and Technology. In addition, Ms. Carter offered comments about Ms. Poore as a champion for students of all backgrounds and that Ms. Poore took her position as a school board member to heart and did an outstanding job.

Mr. Polley had the opportunity to meet with Dr. Kafele last week during his visit to Lynchburg. He also toured Heritage High School today with Senator Newman as part of "Take Your Legislator to School" week. Mr. Polley shared comments about Ms. Poore, as well. He noted that she is very passionate about the students who attend Lynchburg City Schools, and he appreciated her mentorship as a new board member.

Dr. Coleman shared comments about Ms. Poore, who he stated, is one of the most intelligent individuals he has met. "She can take a thought and make anyone understand it. She will be deeply missed by this board and the community."

Mrs. Snyder provided comments about an event that occurred at Thomas C. Miller Elementary School for Innovation which was well attended by members of the community. Mrs. Snyder also provided comments about Ms. Poore stating that she would be greatly missed and that she is an advocate for many individuals. "Ms. Poore spoke for many of us when we didn't know what to say."

Dr. Dolan-Sewell read the following statement: "Jenny Poore, a champion crusader for public education in the city of Lynchburg has worked diligently as a member of the Lynchburg City School Board for a total of five and one-half years. Her manner in dealing with people and issues related to her School Board work earned her favor as a caring and compassionate individual who devoted herself to the service of Lynchburg City Schools. Ms. Poore has been an able spokesperson and supporter of educational causes. She has been encouraging to students and their families. Ms. Poore, a graduate of Heritage High School, was knowledgeable of the challenges that many students, parents, teachers, and staff members encounter. Throughout her service, she was sensitive to the educational needs of ALL students and championed new and creative approaches to education.

"While on the school board, Ms. Poore served on the boards of the Governor's School for Science and Technology and the LAUREL School. She also served on the School Health Advisory Board and the Equity Task Force. She contributed to the decisions and approvals for a new Heritage High School, the hiring of a new superintendent, several budgets in support of staff compensation and student achievements, and a new division-wide Comprehensive Plan. She also contributed to the implementation of new programs, including a new one-to-one technology initiative and the beginning of a process of updating teacher pay scales. Most recently, she passionately supported the development of the Empowerment Academy credit recovery program to help improve the LCS graduation rate.

"Jenny Poore, a person of integrity, by effort and by example, made valuable and far-reaching contributions to public education in Lynchburg, Virginia. And for this I thank her."
