

PART I. GENERAL EXPECTATIONS

T. C. Miller Elementary School for Innovation agrees to implement the following statutory requirements:

- T. C. Miller Elementary will put into operation programs, activities, and procedures for the engagement of parents and families in all Title I, Part A programs, consistent with section 1116 of the Every Students Succeeds Act (ESSA). Those programs, activities, and procedures will be planned and operated with meaningful consultation with parents of participating children.
- T. C. Miller Elementary will work with the school division to ensure the required school-level parent and family engagement policy meets the requirements including, the school-parent compact.
- T. C. Miller Elementary will incorporate this school wide parent and family engagement policy into its Title I/School Improvement Plans. Title I schools have one consolidated plan for 2020-2021.
- In carrying out the Title I, Part A parent and family engagement, T. C. Parent and Family Engagement means the participation of parents in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring—

- (A) that parents play an integral role in assisting their child's learning;

PART II. DESCRIPTION OF HOW T. C. MILLER ELEMENTARY WILL IMPLEMENT REQUIRED SCHOOL WIDE PARENT AND FAMILY ENGAGEMENT POLICY COMPONENTS

1. T. C. Miller Elementary will take the following actions to involve parents in the joint development of its school wide parent and family engagement plan:

T. C. Miller Elementary has a School Improvement Committee that consists of Title I literacy teacher, classroom teachers, the principal, and parent representatives. Parents will be contacted through phone calls about meeting dates and times so they have the opportunity to provide their input. These parents will be included in making decisions about the building level parent and family engagement policy as well as other parent matters.

2. T. C. Miller Elementary will take the following actions to involve parents and families in the process of school review and improvement:

T. C. Miller Elementary will have parent representatives to serve on the School Improvement Committee. The committee will meet at various times during the year to formulate and/or review the Title I/school improvement plan. Parents have the opportunity to provide feedback and make suggestions about various programs that TCM offers.

3. T. C. Miller Elementary will provide the following necessary coordination, technical assistance, and other support to assist in planning and implementing effective parent and family engagement activities to improve student academic achievement and school performance:

Zoom sessions, conferences, phone calls, school Dojo messages, emails, special events, and family fun nights will be held to help improve parental involvement.



4. T. C. Miller Elementary will coordinate and integrate parent and family engagement strategies in Part A with parent and family engagement strategies under the following other programs: Head Start, Virginia Preschool Initiative, McKinney-Vento Homeless Assistance Act, and others as appropriate, by:

Selected Lynchburg City School personnel serve on the Smart Beginnings Coalition and other early childhood education initiatives. Lynchburg City Schools implements the Virginia Preschool Initiative Program and has a Memorandum of Understanding with the local Head Start Program. Lynchburg City Schools employs a full-time Pre-K Coordinator and a full-time Homeless Education Liaison to help meet the needs of all students.

5. T. C. Miller Elementary will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parent and family engagement policy in improving the quality of its Title I, Part A schools. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). T. C. Miller Elementary will use the findings of the evaluation about its parent and family engagement policy and activities to design strategies for more effective parent and family engagement, and to revise, if necessary (and with the involvement of parents) its parent and family engagement policies.

All T. C. Miller Elementary parents and families are asked to complete a-survey. The survey is used to plan for the following year's activities.

- 6. T. C. Miller Elementary will provide opportunities to ensure effective engagement of parents and families and to support a partnership among the school, parents, and the community to improve student academic achievement, through the following activities specifically described below:
 - A. T. C. Miller Elementary will provide assistance to parents of children served by T. C. Miller Elementary, as appropriate, in understanding topics such as the following, by undertaking the actions described in this paragraph.
 - Virginia's academic content standards,
 - Virginia's student academic achievement standards,
 - State and local academic assessments, including alternative assessments,
 - the requirements of Part A,
 - how to monitor their child's progress,
 - how to work with educators, and
 - how to help their children at home

Letters are given to every parent at T. C. Miller Elementary each fall, which addresses the highly qualified status of each employee at the school. Teachers have parent conferences (Zoom



meetings) to give information on student progress and address ways to monitor and to help their children at home. Information regarding student work are given to parents through individual conferences, phone calls, Zoom meetings, interim and quarterly report cards. School event notifications are sent home to parents through school flyers, TCM Newsletter, PTO Zoom meetings, and school Dojo. When students return fulltime information will be sent every week in Monday folders.

B. T. C. Miller Elementary will, with the assistance of the school division, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy and technology training, as appropriate, to foster parent and family engagement, as described below:

During parent and family engagement activities, information about improving literacy in the home environment is shared with parents.

C. The staff of T. C. Miller Elementary will, with the assistance of the school division, learn how to reach out to, communicate with, and work with parents and families as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, as described below:

T. C. Miller Elementary utilizes a parent survey to gather information about activities held at the school. The results of the survey are shared with the faculty. The data is used to plan future parent and family engagement activities and address strengths and any weaknesses noted on the surveys. TCM parent representatives attend the Superintendent's Parent Advisory Committee to provide suggestions and feedback.

D. T. C. Miller Elementary will, to the extent feasible and appropriate, coordinate and integrate parent and family engagement programs and activities with Head Start, and Virginia Preschool Initiative and other programs, and conduct other activities, such as school-level parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:

A brochure is provided by Lynchburg City School's personnel providing information about the Virginia Preschool Initiative, Child Find, and Head Start programs for children 3 and 4 living in the city of Lynchburg. Lynchburg City Schools also provide a Homeless Education Liaison who ensures that all students have access to education as well as transportation.

E. T. C. Miller Elementary will take the following actions to ensure that information related to the school as well as parent programs, meetings, and activities, is sent to the parents and families of



participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

T. C. Miller Elementary takes pride in reaching out to and notifying all families of upcoming events. The EL instructor helps families who have limited English. Newsletters and fliers are sent home, and parents receive automated phone calls about upcoming events. For division level events, the Superintendent Parent Advisory Committee meets to discuss variety of topics, and Channel 17 WLCS is used to disperse information. Our Communications Coordinator sends out newsletters and automated phone calls to parents informing them of up-coming events and meetings. - T. C. Miller Elementary kicks off the year with a Back to School Night *postponed due to Covid-19,* in which families are provided an explanation of TCM being a Title I school and what that actually means to them as TCM families.
- T. C. Miller Elementary holds a "Night Read" night, which includes guest readers and literacy activities for families.
- T. C. Miller Elementary sponsors a variety of parent events, such as Muffins for Moms, Doughnuts for Dads, WatchDogs, and Food Lion Math Night *postponed due to Covid-19*.
- Parents of participating children who receive Leveled Literacy Intervention System or other pullout reading interventions are given a notification of services letter explaining that their children are involved in the Title I program.
- Parents have the right to request and receive timely information on the professional qualifications of their children's teachers.
- An overview of the current school program is provided to all parents. Parents are provided with information about the Virginia Standards of Learning, school report cards, and on the T. C. Miller Elementary website: http://www.lcsedu.net/schools/tcm/ and Lynchburg City Schools website.



- Teachers, parents and students are encouraged to sign a "School, Parent, and Student Compact" at the beginning of the school year which explains each partner's responsibilities in helping each student have a successful school year. *Due to Covid-19 this document was not required, but it can be found on the T. C. Miller website.*
- Parents are strongly encouraged to conference and communicate with their child's teacher, visit their child's classroom on a regular basis, attend family nights, attend performances sponsored by the performing arts team, attend Terrific Kids monthly ceremony, and attend other activities that are offered throughout the school year. *At this time due to Covid-19 only LCS staff and students are allowed in the school building. Parents can call or set up Zoom meetings with staff.*
- T. C. Miller Elementary School's PTO offers many opportunities for parent and family engagement. These include events such as a Trunk or Treat, Holiday Showcase/Holiday Cookies, and Field Day. Parents are encouraged to attend and become involved. At this time due to Covid-19 only LCS staff and students are allowed in the school building. Family activities will be shared in the T. C. Miller newsletter each month until students are back to school for face to face learning.
- During the fall, a Scholastic Book Fair is held *postponed due to Covid-19*.
- Due to COVID-19 parents can schedule Zoom sessions with TCM staff, and Zoom PTO meetings will be held until students are back to school for face to face learning.
